## **Full Crosswinds Membership & One Month Membership Benefits**

### **Corporate, Individual, Gulfstream/Military, Senior and Student Membership**

- Unlimited Greens Fees Monday to Sunday on Championship Course
  - o Walking is permitted for members at any time on the Championship course at no cost.
- Cart fees will apply when member uses a cart.
- Pay a member-guest rate at any GGP course (Dual Membership excluded).
- Juniors who are 16 - 17 years of age must pay a cart fee, when taking a cart by themselves. If they are riding with an adult then there is no cart fee charge.
- Unlimited Greens Fees Monday to Sunday on Par 3 Course
  - o Walking is permitted for members any time at no cost.
- Driving Range: \$3 per bag of range balls, Sign up for Unlimited Range Plan \$200 per year per person.
- Discounted Member-Guest rates for accompanied guests and unaccompanied guests.
  - o Each Member is allowed 4 unaccompanied guests per month (Corporate plan is per day). All tee times for unaccompanied guests must be made by the Member of Crosswinds ahead of time.
  - o Each Member is allowed to bring the same guest a maximum of 4 times a month.
- 15% discount on all in-stock and special ordered merchandise. Discount off of retail price.
- 15% discount on all meals and non-alcoholic beverages. Discount off of retail price.

### **Junior Membership**

### **Par 3 Membership**

- Unlimited Greens Fees Monday to Sunday on Par 3
  - o Walking is permitted for members at any time on the Par 3 course at no cost.
- Cart fees will apply when member uses a cart.
- Juniors who are 16 - 17 years of age must pay a cart fee, when taking a cart by themselves. If they are riding with an adult then there is no cart fee charge.
- Driving Range: \$3 per bag of range balls, Sign up for Unlimited Range Plan \$200 per year per person.
- Discounted Member-Guest rates for accompanied guests and unaccompanied guests.

**Membership Cancellation/Suspension Policy**

All memberships that are voluntarily cancelled by a member prior to the membership expiration date will be assessed the balance due of the remainder of the membership, which must be paid in full at conclusion of membership. All outstanding balances will be assessed a monthly finance charge of 1.5 percent. Any member that requests a suspension must pay in full any account balance and will be granted a 60 day suspension.
